

**HIGHLANDS CHURCH - HIGHLANDS RIDERS  
PARTICIPANT WAIVER & RELEASE OF LIABILITY  
ASSUMPTION OF RISK & INDEMNITY AGREEMENT**

**Waiver:** I, the undersigned participant (hereinafter "Participant") in consideration of participating in motorcycle rides and/or events organized and/or sponsored by the Highlands Riders, or any person or group within Highlands Church, (hereinafter "Riders") on behalf of myself and my heirs, assigns, and next of kin, HEREBY WAIVE AND RELEASE HIGHLANDS CHURCH AND HIGHLANDS RIDERS, its Pastors, directors, officers, employees, managers, agents and members (hereinafter "Highlands") FROM LIABILITY FROM ANY AND ALL CLAIMS, INCLUDING THE NEGLIGENCE OF HIGHLANDS, resulting in personal injury, accidents, or illness (including death) and property loss arising from my participation in Highlands Riders organized and/or sponsored motorcycle rides or events.

**Assumption of Risks:** I understand that the motorcycle rides or events I will participate in may cause injuries, including bodily injury or damage to personal property. The risks of participating in these activities and/or events range from minor injuries to major and catastrophic injuries, including paralysis and death. I have considered the potential risk involved and choose to participate in the motorcycle rides and events organized and/or sponsored by Highlands or Riders. By signing this agreement, I EXPRESSLY AND WILLINGLY ASSUME ANY AND ALL RISKS incident to my participation in motorcycle rides and events organized and/or sponsored by Highlands or Riders.

**Hold Harmless:** I will not hold Highlands or Riders responsible even if injuries were caused by a third party and/or negligence on my part or Highlands or Riders or any other party under or affiliated with Highlands. If any member, guest, invitee, employee, agent, heir, assign, next of kin, or any other person makes a demand, files a lawsuit, or otherwise makes a claim against Highlands or Riders arising out of my participation in Highlands Riders' motorcycle rides or events I WILL INDEMNIFY, DEFEND AND HOLD HIGHLANDS HARMLESS.

I have read and fully agree to the terms of this agreement. I UNDERSTAND THAT BY SIGNING THIS AGREEMENT I HAVE GIVEN UP CONSIDERABLE FUTURE LEGAL RIGHTS. I have signed this agreement freely, voluntarily, under no duress or threat of duress without inducement, promise, or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional waiver and release of all liability to the fullest extent of the law. I am 18 years of age or older and mentally competent to grant this waiver.
